

COUNTY GIS MINOR EDITS

1. **Unintended Census block oversights and miscodes.** There are very minor blocks that look as though they were unintentionally miscoded, oversights that can be easily cleaned up. These changes are highly recommended to avoid sliver Precincts and unnecessary Ballot Types. There are 14 blocks and a total population of 29 involved in these recommendations.

In the Rancho Murieta area south of Jackson Rd, the Census Block Lines that existed in the previous Census are no unfortunately longer present. It is acknowledged that NDC and the Supervisors chose the CDP boundary of Rancho Murieta. However, reassigning these two Census Blocks will represent the "best fit", with the two Districts listed at left which better define Rancho Murieta, and will align with the voters who are voting on those Districts.
