PUBLIC COMMENT PROCEDURES In compliance with directives of the County, State and Centers for Disease Control and Prevention (CDC), the meeting will be live stream and open to public attendance pursuant to guidelines related to social distancing and minimizing person-to-person contact. **IN-PERSON PUBLIC COMMENT** Members of the public may address the Board in-person to make a public comment. A facemask and social distancing are required while inside the County Administration Building and Board Chambers. Seating is limited and available on a first-come, first-served basis. Members of the public addressing the Board will be required to complete and submit a speaker request form to Clerk staff. The Chairperson will invite each individual to the podium to make a verbal comment during the public comment period for each agenda item or off-agenda matter. **TELEPHONIC PUBLIC COMMENT** On the day of the meeting dial (916) 875-2500 to make a verbal public comment (follow the agenda and instructions).
